

TERMS AND CONDITIONS

These terms and conditions (the “Terms and Conditions”) govern the use of **www.atlanticfreedomministries.com** (the “Site”). This Site is owned and operated by Atlantic Freedom Ministries. This site is a non-profit e-commerce website.

By using this Site, you indicate that you have read and understand these Terms and Conditions and agree to abide by them at all times.

Intellectual Property

All content published and made available on our Site is the property of Atlantic Freedom Ministries and the Site’s creators. This includes but is not limited to images, text, logos, documents, downloadable files, and anything that contributes to the composition of our site.

Acceptable Use

5. Click **Cancel Subscription**.
6. Click **Yes, Cancel** to confirm.

Payments

We accept the following payment methods on our Site:

When you provide us with your payment information, you authorize our use of and access to the payment instrument you have chosen to use. By providing us with your payment information, you authorize us to charge the amount due to this payment instrument.

Shipping and delivery

- Standard delivery by post. Delivery takes 5-7 business days; or
- Express shipping by post. Delivery takes 1-3 days.

Delivery will take place as soon as reasonably possible, depending on the delivery method selected. Delivery times may vary due to unforeseen circumstances. Please note that delivery times do not include weekends or statutory holidays.

You will be required to pay delivery charges in addition to the price for the goods you purchase.

If you purchase goods from us from delivery to a destination outside Canada, your purchase may be subject to import duties and taxes by the destination country.

You are responsible for paying any such duties or taxes. Please contact your local customs office for more information before making a purchase. We are not responsible for the payments of any such duties or taxes and are not liable for any failure by you to pay them.

You are required to provide us with a complete and accurate delivery address, including the name of the recipient. We are not liable for the delivery of your goods to the wrong address or wrong person as a result of you providing us with inaccurate or incomplete information.

Refunds

Refunds for goods

Refund requests must be made within 30 days after receipt of your goods.

Refund for Services

Returns

If there is a conflict between these Terms and Conditions and that legislation, the mandatory provisions of the legislation will apply.

Limitation of Liability

Atlantic Freedom Ministries and our directors, officers, agents, employees, subsidiaries, and affiliates will not be liable for any actions, claims, losses, damages, liabilities, and expenses including legal fees from your use of the Site.

Indemnity:

Severability

All other provisions will not be affected by the removal and the rest of these Terms and Conditions will still be considered valid.
